Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Sixth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of the fabric or plastic tape measures of accuracy class-III of series "RMT" and with brand name "GOLDEN TAPE MEASURES" (hereinafter referred to as the said model) manufactured by M/s Ideal Measure Tape Products, 117, Gurwar Peth, Fulwala Chowk, Pune-411042, Maharashtra and which is assigned the approval mark IND/09/24/017 (the picture of the model is given below as Figure 1);

The said model is a plastic tape measure which is used for measurement of length, where the rigid length measures is not convenient or practicable. The maximum length 2m and value of graduation is 1mm. The results of measurements are indicated by graduation lines on the tape.





A typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said Model shall also cover the plastic tape measures of similar make, accuracy and performance of same series with nominal length of up to 2m manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved Model has been manufactured.
