Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

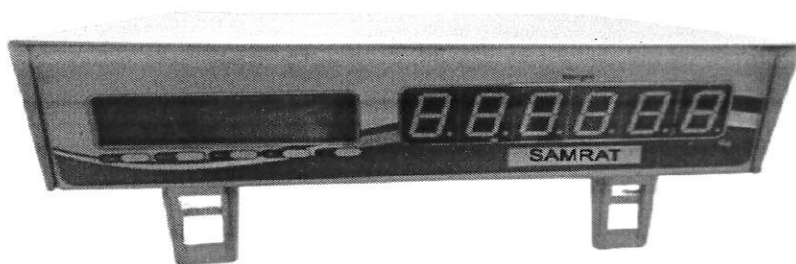
Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of non-automatic weighing instrument with digital indication of medium accuracy (accuracy class-III) of series "SRSW" and with brand name "SAMRAT" (hereinafter referred to as the said model), manufactured by M/s Sriram Sales Agency, Gaylord Plaza, Shop No.-LG - 19, Purana Bazar, Pani Tanki, Dhanbad, Jharkhand- 826001 and which is assigned the approval mark IND/09/24/111 (the picture of model is given below as figure 1);

The said model is a strain gauge type load cell based non-automatic weighing instrument with a maximum capacity of 40tonne and minimum capacity of 200kg. The verification scale interval (e) is 10kg. It has subtractive tare. The light emitting diode (LED) display indicates the weighing result and liquid crystal display (LCD) is for other information. The instrument operates on 230Volts, 50Hertz alternating current power supply. It is an electronic weighbridge type weighing instrument.

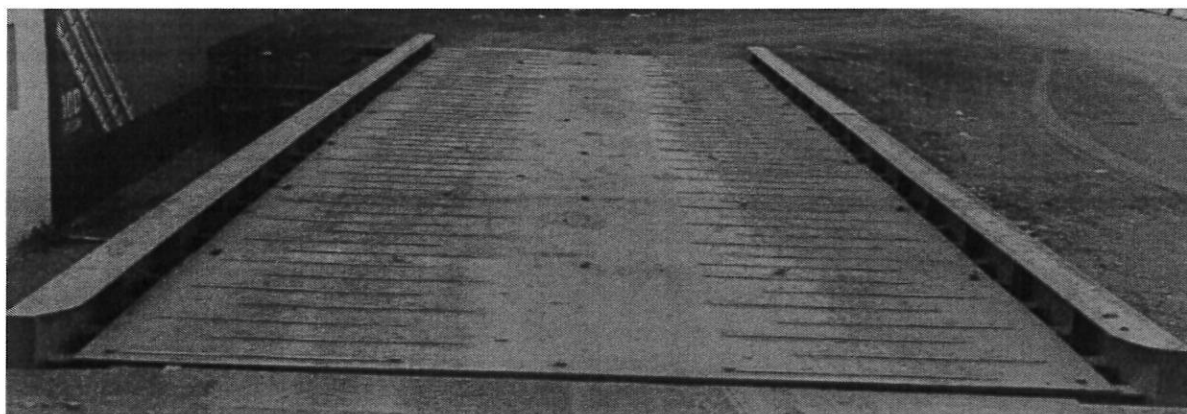
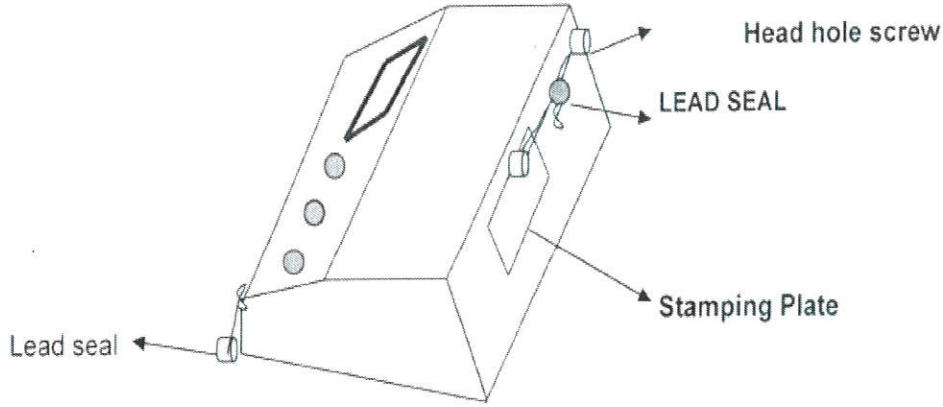




Diagram of stamping and sealing for

Sealing is done by passing the sealing wire through the holes provided on the body of machine. A lead seal is put at the end of the wire for stamping purpose (a typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2). A dip switch has also been provided in mother board to disable access to external calibration.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with capacity above 5tonne and up to 150tonne with number of verification scale interval (n) in the range of 500 to 10000 for 'e' value of 5g or more and with 'e' value of 1×10^k , 2×10^k or 5×10^k , where k is a positive or negative whole number or equal to zero manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
