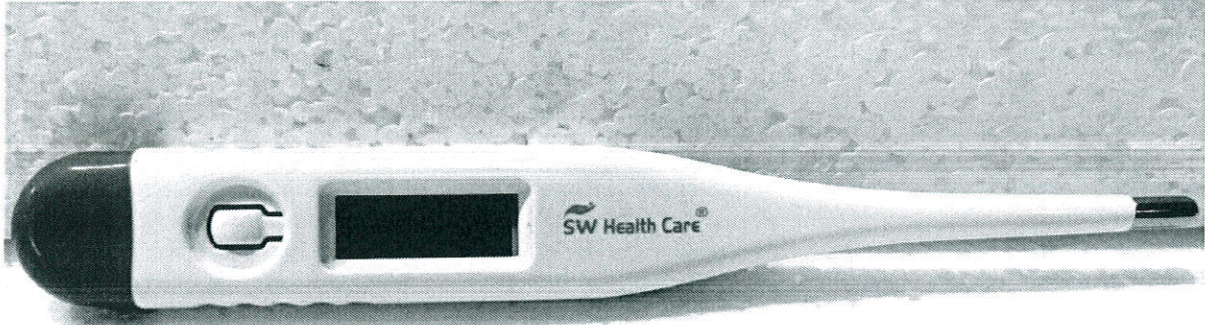

Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of clinical electrical thermometer with maximum device with digital indication of accuracy class-II of series "SWDT100" with brand name "SW HEALTH CARE" ( hereinafter referred to as the said model), manufactured by M/s SW Health Care Private Limited, Plot No. 50, Corner, Pocket-I, Sector -4, Bawana Industrial Area, Bawana, North West Delhi-110039 and which is assigned the approval mark IND/09/24/121 (the picture of the model is given below as Figure 1);

Range = 32°C to 42.9°C, Resolution: 0.1 °C , LCD display , Class = II,  
Brand Name =SW HEALTH CARE, Series = SWDT100

The said model is a clinical electrical thermometer with maximum device with measuring range of 32.0 degree celsius to 42.9 degree Celsius. Such instruments are designed to measure human or animal body temperature. They indicate a maximum temperature measured after a steady state is reached or predicted after a time specific to the design of the instrument. Until the maximum temperature is indicated, the actual temperature may be indicated by the thermometer. It operates on 1.5V direct current power supply with digital indication of temperature, scale interval or digital increment of 0.1 degree celsius and display is liquid crystal display (LCD) type.
