Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of non-invasive automated sphygmomanometer with digital indication of series "HEM-7143T1" with brand name "OMRON" (hereinafter referred to as the said model), manufactured M/s Omron Healthcare Co., Ltd, 53, Kunotsubo, Terado-cho, Muko Kyoto, 617-0002, Japan and imported & marketed in India without any alteration before or after sale by M/s Omron Healthcare India Private Limited, 6th Floor, B-Block Sewa Tower, Plot no.19 Sector-18, Udyog Vihar, Maruti Industrial Complex, Gurgaon- 122008, Haryana and which is assigned the approval mark IND/09/24/129 (the picture of the model is given below as Figure 1);



The said model works on the principle of oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model have measuring range of pressure 0-299 mmHg and scale interval is 1 mmHg with digital indication of liquid crystal display (LCD). It operates on 4x1.5 V DC (AA) power supply.
