The said model works on the principle of oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model have measuring range of pressure 0-299 mmHg and scale interval is 1 mmHg with digital indication of liquid crystal display (LCD). It operates on 4x1.5 V DC (AA) power supply.
