

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per OIML R 137, the Central Government hereby issues the certificate of approval of Diaphragm Gas Meter with mechanical counter of accuracy class 1.5 of "G10S" series with brand name "CAPITAL" (hereinafter referred to as the said model), manufactured M/s Capital Innotech Private Limited, E-100, Mewar Industrial Area, Madri, Udaipur, Rajasthan-313003 and which is assigned the approval mark IND/09/24/133 (the picture of the model is given below as Figure 1);





Refer to attached photo above, total 3 Seals (123) are installed on gas meter's counter cover with suitable approved design, size and strength. If try to tamper with the counter cover, it will leave indelible trace on seals and easy be found. These 3 seals are pre-equipped in ClPL factory. A typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2.
