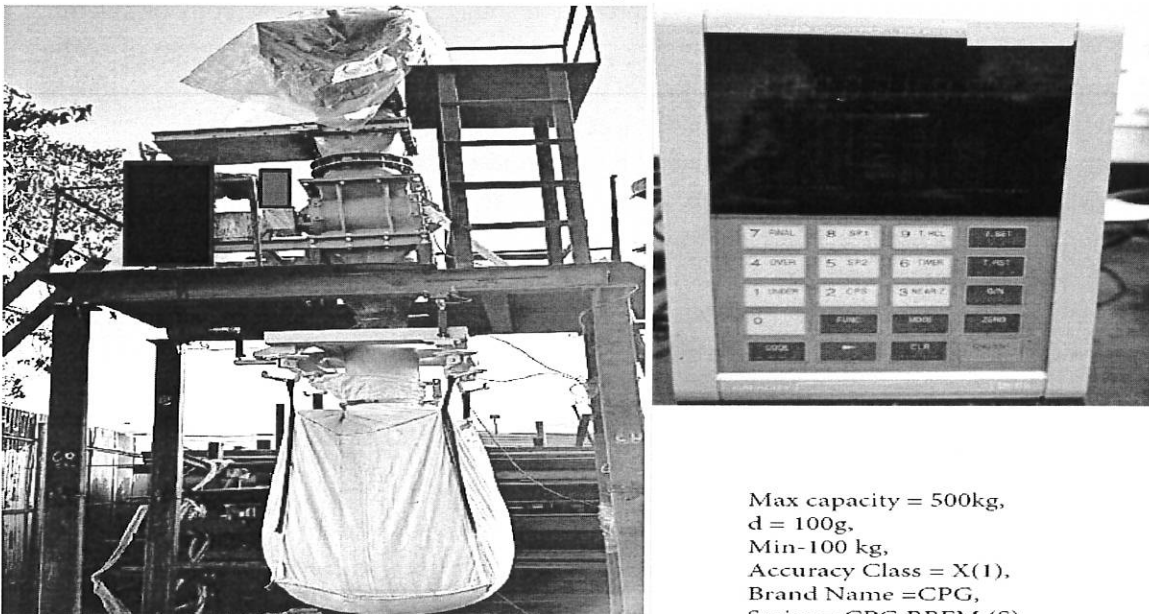
Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of automatic gravimetric filling instrument belonging to accuracy class X(x), where x=1 of series "CPG BBFM (S)" and with brand name "CPG" (hereinafter referred to as the said model), manufactured by M/s Chanderpur Works Private Limited, #1, Jorian, Delhi Yamunanagar Road, Yamunanagar, Haryana-135001 and which is assigned the approval mark IND/09/24/146 (the picture of the model is given below as Figure 1);

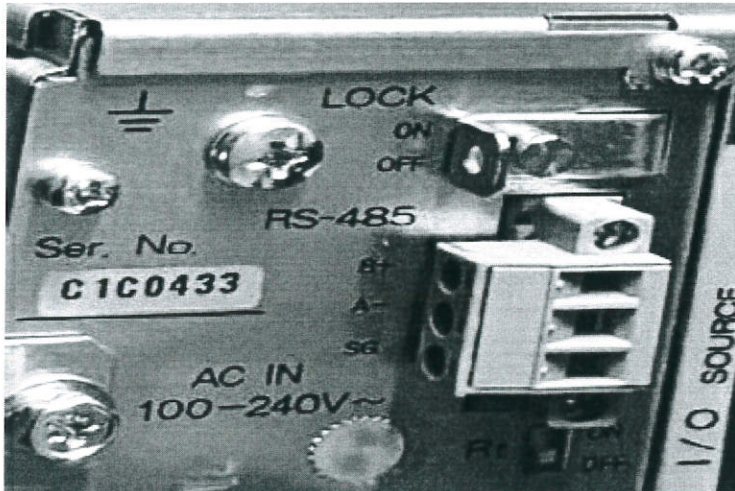
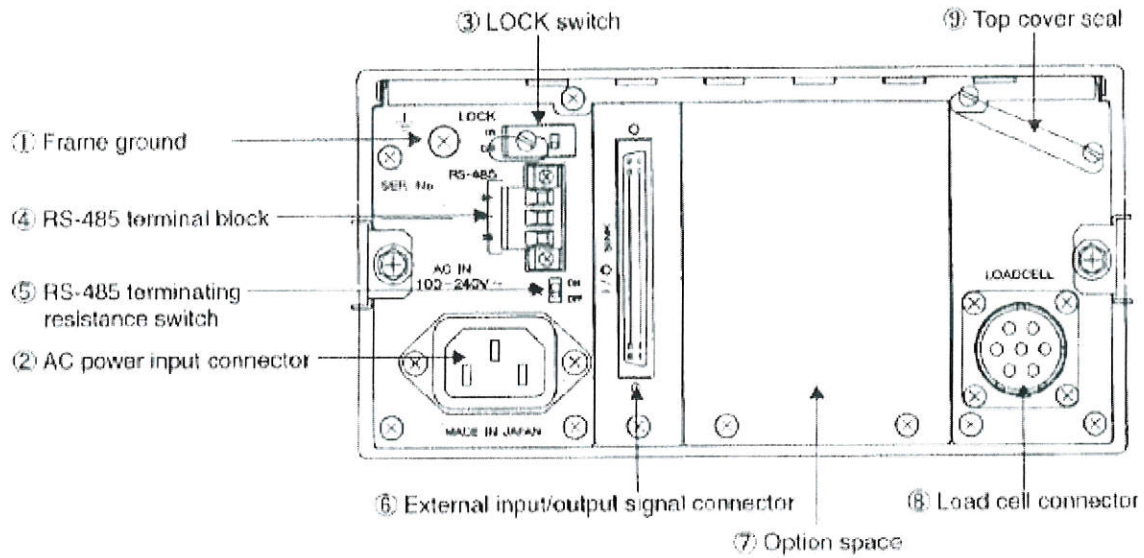

Sealing is done by passing the sealing wire through the holes provided on the body of machine. A lead seal is put at the end of the wire for stamping purpose (a typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2). A dip switch has also been provided in mother board/PCB to disable access to external calibration.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the automatic gravimetric filling instruments of similar make, accuracy and performance of same series with maximum capacity from 100kg and up to 1000kg manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
