The said model is an electronic and infrared sensor based digital clinical infrared thermometer for intermittent determination of patient temperature with measuring range of 34.5 degree celsius to 43.0 degree celsius. It operates on 9 VDC battery direct current power supply with digital indication of temperature, scale interval or digital increment of 0.1 degree celsius and display is light emitting diode (LED) type.
