Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of non-invasive automated sphygmomanometer with digital indication of series "AP-4100H" with brand name "APOLLO PHARMACY / EXPERT" (hereinafter referred to as the said model), manufactured by M/s Conceptreneur Ventures Pvt. Ltd., 1st Floor, 114/3A, Bela Plot Building, 24A, Jain Society Sion West, Mumbai, Suburban, Maharashtra 400022 and which is assigned the approval mark IND/09/24/177 (the picture of the model is given below as Figure 1);





The said model works on the principle of oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model have measuring range of pressure 0-299 mmHg and scale interval is 1 mmHg with digital indication of liquid crystal display (LCD). It operates on AA Batteries Power Adapter AC 90-260V power supply.
