




Figure-2 (Sealing Provision)

The mechanical totalizer is sealed with tow seals and in case of a meter equipped with a pressure test point, an additional seal is privided for the pressure test point with wire and lead. A typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2.
