Certificate of Approval of Model/ मॉडल का अनुमोदन प्रमाणपत्र

Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Sixth of the Legal Metrology (General) Rules, the Central Government hereby issues the certificate of approval of steel tape measures of accuracy class-III of series "SMMH" and with brand name "WIC" (hereinafter referred to as the said model) manufactured by M/s Weighing India Corporation, 155/230/232, Jangalpur Road, Kolkata-700081 (North 24 Parganas) (West Bengal) and which is assigned the approval mark IND/09/24/ 212 (the picture of the model is given below as Figure 1);

The said model is a fabric or plastic tape measures which is used for measurement of length. The maximum length 2m and value of graduation is 1mm. The results of measurements are indicated by graduation lines on the tape. It may be used as stadiometer for measuring height.

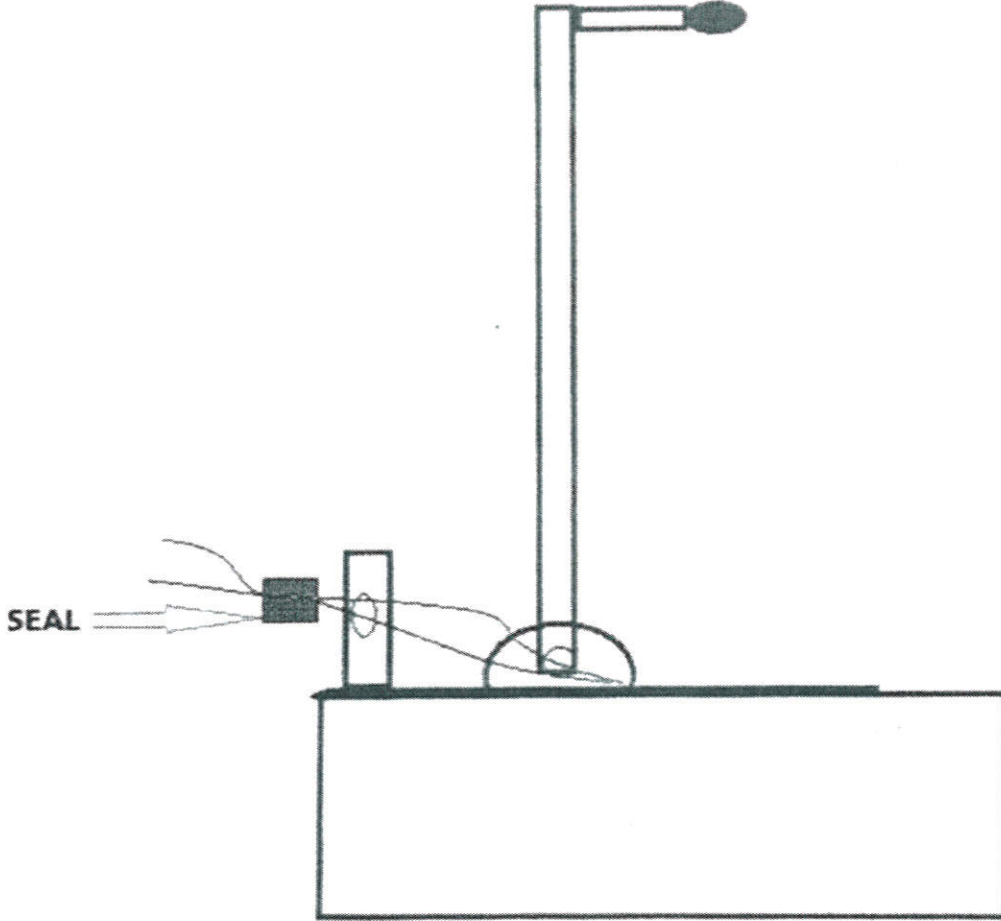

The stamp of verification is affixed on the metal strip provided at the beginning of the tape measure as shown in the figure above.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said Model shall also cover the steel tape measures of similar make, accuracy and performance of same series with nominal lengths up to 2m manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved Model has been manufactured.
