

Certificate of Approval of Model/ मॉडल का अनुमोदन प्रमाणपत्र

Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of mechanical counter machine of series "ABC" and with brand name "ASIT" (hereinafter referred to as the said model), manufactured by M/s. ASIT BENT COUNTER SCALE, Village-Khoriop New market, P.O. – Khoriop, P.S.- Amta, Howrah-711 401 and which is assigned the approval mark IND/09/24/227 (the picture of the model is given below as Figure 1);

The said model is a mechanical counter machine working on the principle of lever with a maximum capacity of 5kg and sensitivity is 6g.





Scaling is done by adjustment box is properly sealed with stud or plug passing the scaling wire. Such a plug or stud is irremovable (a typical schematic diagram of scaling provision to prevent the fraudulent practices of the model is given above as Figure 2).

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011 the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with maximum capacity from 500g and up to 20kg manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
