
Certificate of Approval of Model/ मॉडल का अनुमोदन प्रमाणपत्र

Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions:

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per OIML R 120, the Central Government hereby issues the certificate of approval of the model of "Proving Tanks" with series "KSPM" and with brand name "SAMSAI" (hereinafter referred to as the said model), manufactured by M/s Samsai Electronics, Shop No.-202A, Eagle Pride Mall, Near Hotal Vaibhav, Burudgaon Road, Ahmednagar-414001 (M.S.) and which is assigned the approval mark IND/09/24/256 (the picture of the model is given below as Figure 1);

The said model is a Proving Tanks with maximum capacity of 1000 liter and range of adjustment ± 10 liter with scale interval is 250ml.



The sealing is done by a seal wire is passed through the holes provided at the top graduated scale which is sealed to stop the fraudulent practices. A typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with maximum capacity of 5000 liter manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
