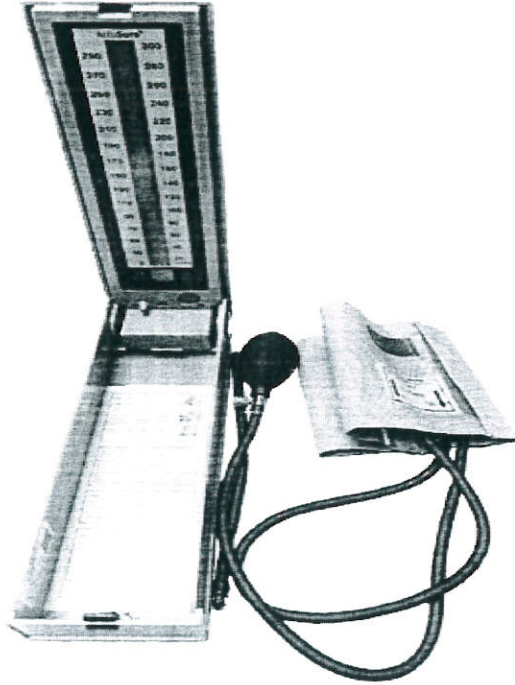

Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of non-invasive aneroid sphygmomanometer of series "BK" with brand name "ACCUSURE" (hereinafter referred to as the said model), manufactured by M/s Macrad Medicals Private Limited, B-277, Phase-I, Okhla Industrial Area, South East Delhi- 110020 and which is assigned the approval mark IND/09/24/92 (the picture of the model is given below as Figure 1);

The said model works on the principle of Auscultatory method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model have measuring range of pressure 0-300 mmHg and scale interval 2mmHg with digital indication of liquid crystal display (LCD). It operates on 3x1.5 V direct current power supply.
