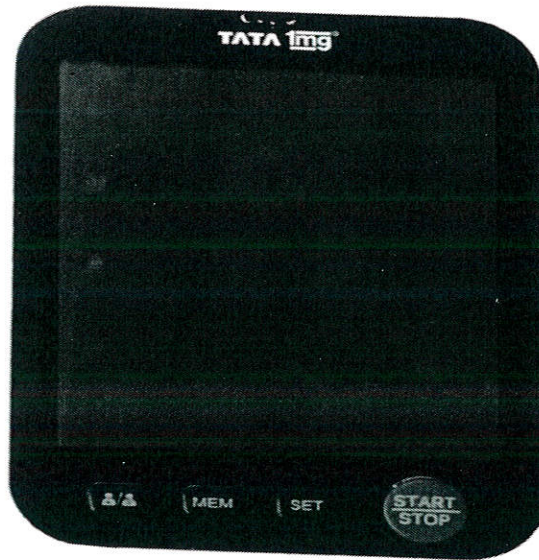

The said model works on the principle of the oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model has measuring range of pressure 0-280 mmHg and scale interval 1mmHg with digital indication of liquid crystal display (LCD). It operates on 6 V direct current power supply.
