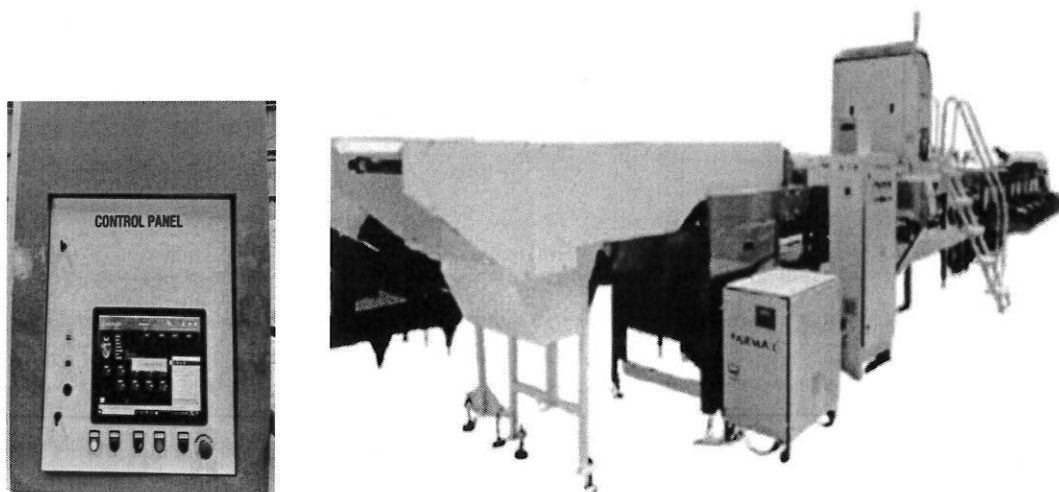
Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per OIML R 51, the Central Government hereby issues the certificate of approval of the model of Automatic Catch weighing instrument( Grading Instrument) with accuracy class-Y(b) of series "Prime 2 Lane Grader" and with brand name " HORTISORT" ( hereafter in this notification referred to as the said model), manufactured by M/s. Zentron Labs Private Limited, G.001 &002 Touch down, HAL Industrial Estate, Vibhuthipura, Bangalore-560037 and which is assigned the approval mark IND/09/25/ 33 (the picture of the model is given below as Figure 1);

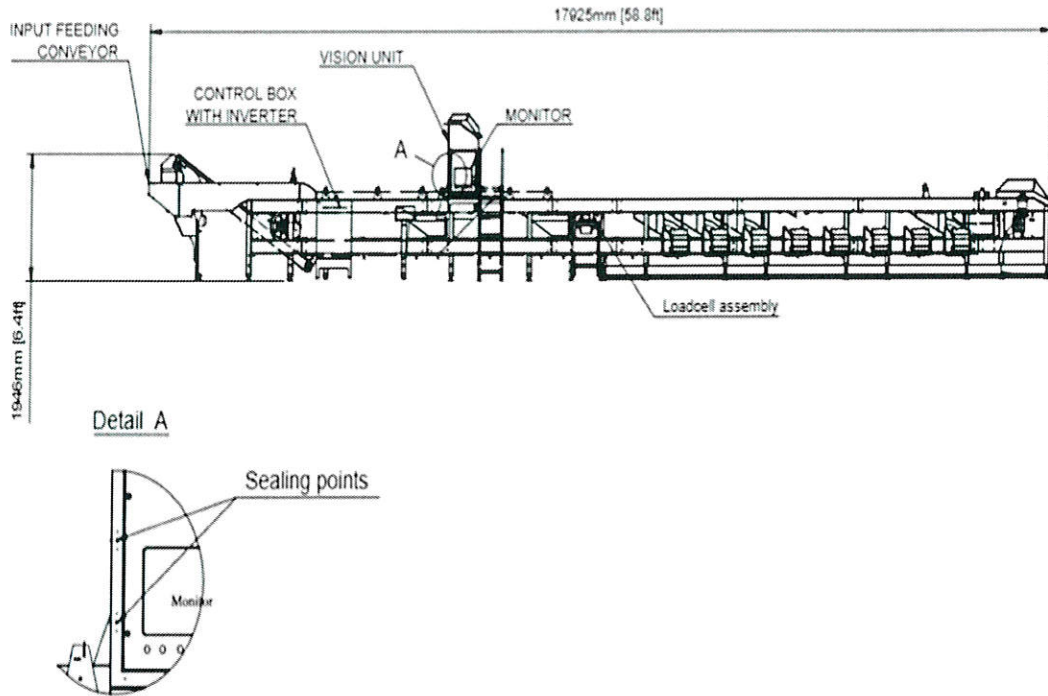

Sealing is done by passing the sealing wire into the screw provided on body of the instrument (a typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2). A dip switch has also been provided in mother board to disable access to external calibration.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with capacities upto 5 kg manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
