Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of non-invasive automated sphygmomanometer of series "Tango M2" with brand name "SunTech" (here in after referred to as the said model), manufactured by M/s Suntech Medical Inc., 5827 South Miami Boulevard, Suite 100, Morrisville, NC 27560, United States of America and imported and marketed in India without alteration by M/s Halma India Private Limited, 7, Tower C, Gate No:2, Prestige Shantiniketan, Whitefield Main Road, Mahadevapura, Bengaluru, Karnataka-560048 and which is assigned the approval mark IND/09/25/ 110 (the picture of the model is given below as Figure 1);

The said model works on the principle of the oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model has measuring range of pressure 0-280 mmHg and scale interval 1mmHg. A LCD display indicates the results of the measurement and the instrument operates on 9V DC power supply.
