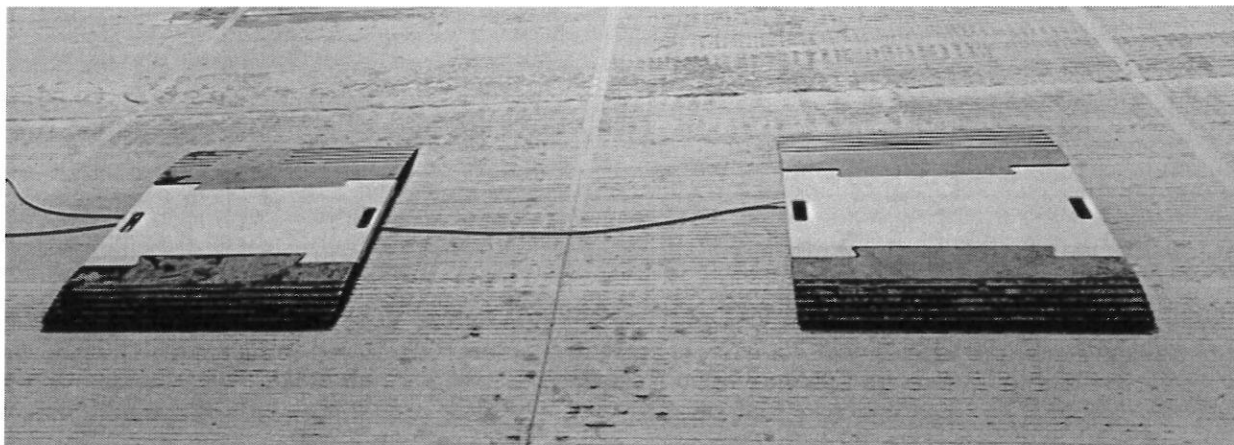
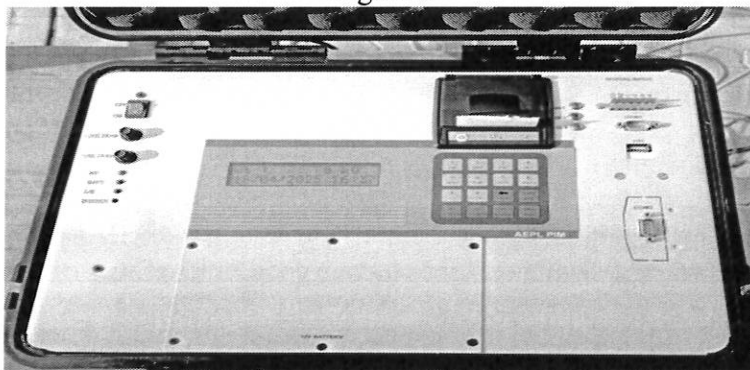
Certificate of Approval of Model/ मॉडल का अनुमोदन प्रमाणपत्र

Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011 the Central Government hereby issues the certificate of approval of automatic instrument for weighing road vehicles in motion and measuring axle loads of accuracy class vehicle mass-5, single axle load and group axle load -E of series "AEPL PIM" and with brand name "APPALTO" (hereafter in referred to as the said model), manufactured M/s. Appalto Electronics Pvt.Ltd. Plot No: 24-25, IT Park Sinhasa, Dhar Road, Indore-452013, Madhya Pradesh and which is assigned the approval mark IND/09/25/157 (the picture of model is given below as figure 1.);

The said model is portable weigh pads (strain gauge type) load cell of Make- APPALTO, Accuracy Class -C3, maximum capacity-10 tonne each based automatic instrument for weighing road vehicles in motion and measuring axle loads with a maximum capacity of 20 tonne (Two no portable pads of 10 tonne each) and minimum capacity of 500kg. The scale interval (d) is 50kg. Its speed range is 1km/h to 8 km/h. The liquid crystal display (LCD) indicates the weighing result with OTP provision for calibration. The instrument operates on 230Volts, 50Hertz alternating current power supply.

Provision for Sealing & Stamping of Electronic Digitizer for Weighbridge:-

Sealing Point is affixed on the stamping plate incorporated with the upper and lower body cover to avoid the fraudulent use in weighing process. There are two sealing provided on the body at the opposite corner. Sealing wires are also sealed by the lead seal by which nobody can open the machine without breaking the seal.
A dip switch is provided in the mother board of the indicator to disable access to external calibration.

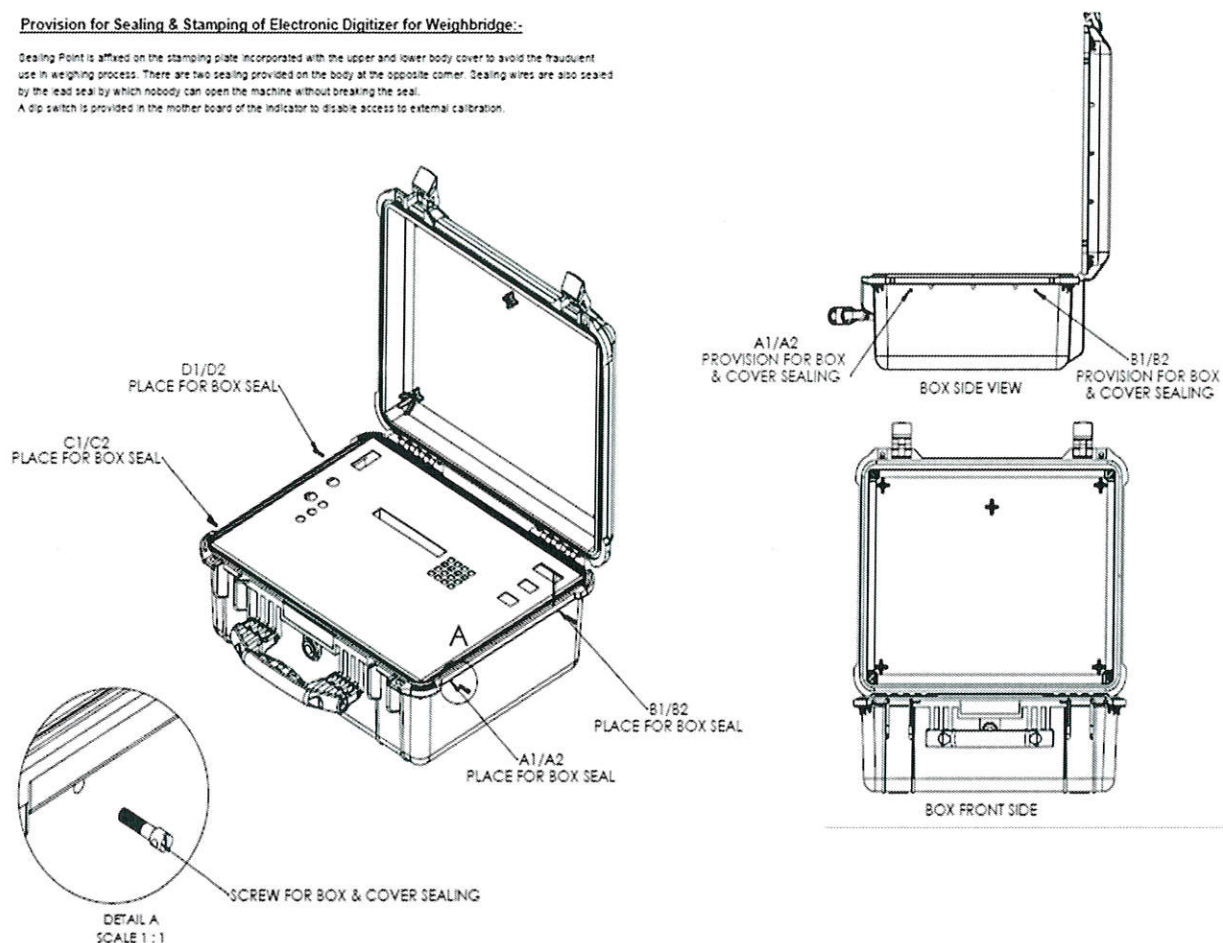

A typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2. A dip switch has also been provided in mother board/PCB to disable access to external calibration.

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with maximum capacity up to 50 tonne per axle and speed of 1 to 8 km/h manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
