Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions:

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of non-invasive automated sphygmomanometer of series "B21i" with brand name "BPL" (here in after referred to as the said model), manufactured by M/s BPL Medical Technologies Private Limited, 11<sup>th</sup> KM, Bannerghatta Road, Arakere, Bengaluru, Karnataka-560076 and which is assigned the approval mark IND/09/25/140 (the picture of the model is given below as Figure 1);





Range = 0 - 280 mmHg, Resolution = 1 mmHg, Display = LCD, Brand = BPL, Series = B21i

The said model works on the principle of the oscillometric method wherein cuff is placed on the arm for measuring aerial blood pressure. The said model has measuring range of pressure 0-280 mmHg and scale interval 1mmHg. A LCD display indicates the results of the measurement and the instrument operates on 6V DC power supply.
