Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of non-automatic weighing instrument with analog indication of ordinary accuracy (accuracy class-IIII) of series "TI-PWSM" and with brand name "TECHNOMATE" (hereinafter referred to as the said model), manufactured by M/s. AADHUNIK ENGINEERING, Tupudana, Hatia Ranchi, Jharkhand - 834003 and which is assigned the approval mark IND/09/25/ 288 (the picture of model is given below as figure 1);

The said model is a spring and lever based non-automatic weighing instrument with a maximum capacity of 120kg and minimum. capacity of 5kg. The verification scale interval (e) is 500g. The pointer on dial indicates the weighing result. It is used as Mechanical Personal Weighing Balance Scale type weighing instrument.



Sealing is done by passing the sealing wire through the holes provided on the adjustment screw. The stamping point is provided on the front side (a typical schematic diagram of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2).

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance of same series with maximum capacity up to $100 \, \mathrm{kg}$ with number of verification scale interval (n) in the range of $100 \, \mathrm{to} \, 1000$ for 'e' value of $5 \, \mathrm{g}$ or more and with 'e' value of $1 \, \mathrm{x} \, 10^{\mathrm{k}}$, $2 \, \mathrm{x} \, 10^{\mathrm{k}}$ or $5 \, \mathrm{x} \, 10^{\mathrm{k}}$, where k is a positive or negative whole number or equal to zero manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
