Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of non-automatic weighing instrument with digital indication of series "AW-19" and with brand name "APEX A" (hereinafter referred to as the said model), manufactured by M/s. 

Sealing is done by passing the sealing wire through the holes provided on the body of machine. A lead seal is put at the end of the wire for stamping purpose (sealing diagram and photograph to prevent the fraudulent practices of the model is given above as Figure 2). A dip switch has also been provided in mother board/PCB to disable access to external calibration.
