Certificate of Approval of Model/ मॉडल का अनुमोदन प्रमाणपत्र

Whereas the Central Government, after considering the report submitted to it by the prescribed authority, is satisfied that the model described in the said report is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Seventh of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of mechanical counter machine (double pan type) (hereinafter referred to as the said model) with brand name “AKP” and series “CAKP”, manufactured by M/s Ajit Kumar Paul, Ambica Kundu Bye Lane, P.O.- Santragachi, P.S.- Jagacha, Dist.- Howrah, West Bengal – 711104 and which is assigned the approval mark IND/09/25/497 (the picture of model is given below as figure 1);

The said model is an equal arms weighing instrument working on the principle of lever with a maximum capacity of 5kg and sensitivity is 6g. The position of equilibrium is obtained with the help of pointer in the middle of beam.

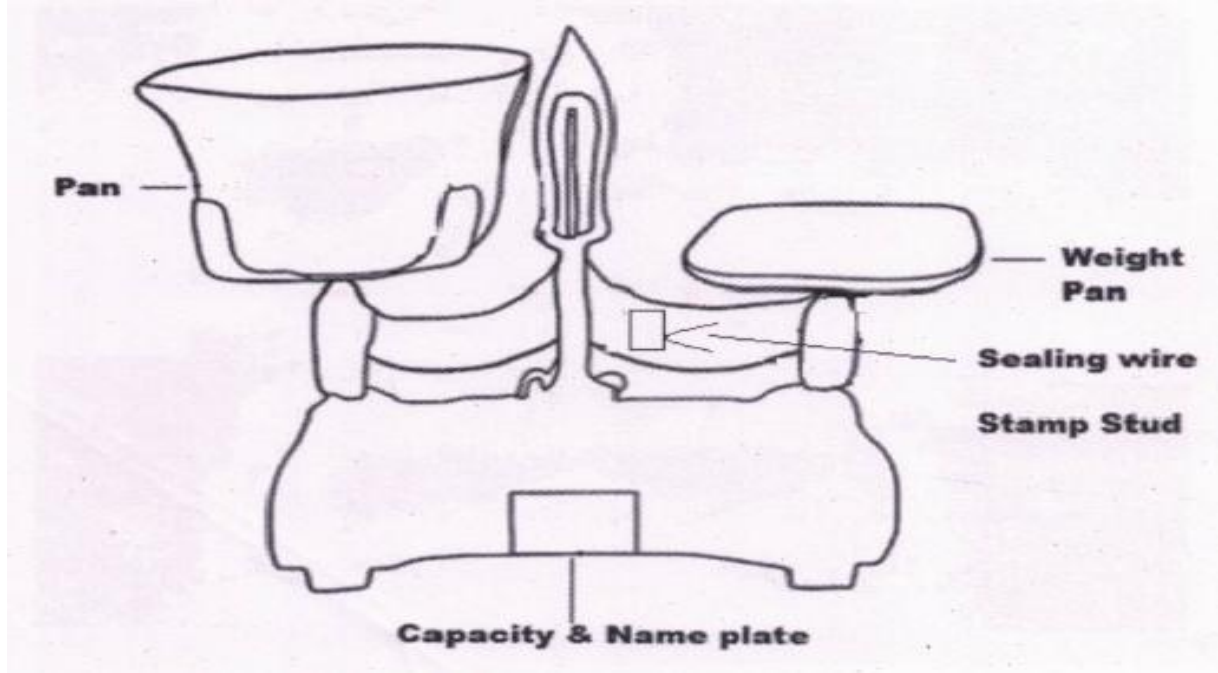

Sealing/ Stamping is done with a plug or stud of lead on the visible part of the beam as shown in figure 2. Such a plug or stud is made irremovable by undercutting it. A typical schematic diagram for receiving the stamp or seal of the verification authority is given above as figure 2).

Further, in exercise of the power conferred by sub-rule (9) of rule 8 of the Legal Metrology (Approval of Models) Rules, 2011, the Central Government hereby declares that this certificate of approval of the said model shall also cover the weighing instruments of similar make, accuracy and performance with capacity upto 50kg manufactured by the same manufacturer in accordance with the same principle, design and with the same materials with which, the said approved model has been manufactured.
