Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of "Taximeter" (hereafter in referred to as the said model) of series "TSM-01" and with brand name "TRIDENT" manufactured by M/s. TRIDENT SYSTEMS, LOKANATH ROAD, HARACHANDI SAHI , PURI Odisha-752001 and which is assigned the approval mark IND/09/26/ 171 (the picture of the model is given below as Figure 1);

The said model of "Taxi Meter" is a measuring instrument which totalizes continuously and indicates at any moment of the journey the charges payable by the passenger of a public vehicle as function of the distance travelled and, below a certain speed, of the length of time occupied, independent of supplementary charges, according to the authorised tariffs.

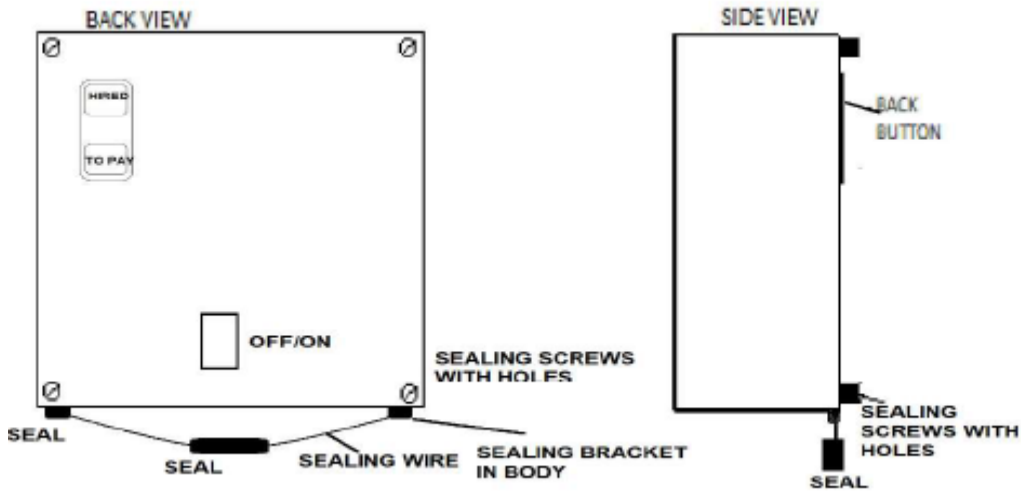
