Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per Schedule Eighth of the Legal Metrology (General) Rules, 2011, the Central Government hereby issues the certificate of approval of the model of non-invasive automated sphygmomanometer of series "AP-1500T" with brand name "Apollo Pharmacy" (here in after referred to as the said model), manufactured by M/s Conceptreneur Ventures Private Limited, 114/3a, Bela Plot, Road No: 24A, Sion, Mumbai City, Maharashtra – 400022 and which is assigned the approval mark IND/09/26/222 (the picture of the model is given below as Figure 1);

The said model works on the principle of the oscillometric method wherein cuff is placed on the arm for measuring arterial blood pressure. The said model has measuring range of pressure 0-280 mmHg and scale interval 1mmHg. A LCD display indicates the results of the measurement and the instrument operates on 5V DC power supply (Lithium-ion battery). The software version of the model is V1.2.0.zip and checksum is C62e52db23db72bf9b8fa98cf156c949.
