Whereas the Central Government, after considering the report submitted to it by prescribed authority, is satisfied that the model described in the said report (see the figure given below) is in conformity with the provisions of the Legal Metrology Act, 2009 (1 of 2010) and the Legal Metrology (Approval of Models) Rules, 2011 and the said model is likely to maintain its accuracy over periods of sustained use and to render accurate service under varied conditions;

Now, therefore, in exercise of the powers conferred by section 22 of the Legal Metrology Act, 2009 (1 of 2010) read with sub-rule (6) of rule 8 and sub-rule (4) of rule 11 of the Legal Metrology (Approval of Models) Rules, 2011, as per OIML R 49, the Central Government hereby issues the certificate of approval of model of water meter (Ultrasonic) of accuracy class 2 (hereinafter referred to as the said model) of series "IUW" and with brand name "ZENNER" manufactured by M/s Zenner Aquamet India Private Limited, Plot No.260, Sector-68, IMT Faridabad, Haryana-121004 and which is assigned the approval mark IND/09/26/ 403 (the picture of the model is given below as Figure 1);

The said model is a water meter (ultrasonic) which is based on principle of ultrasonic sensing.

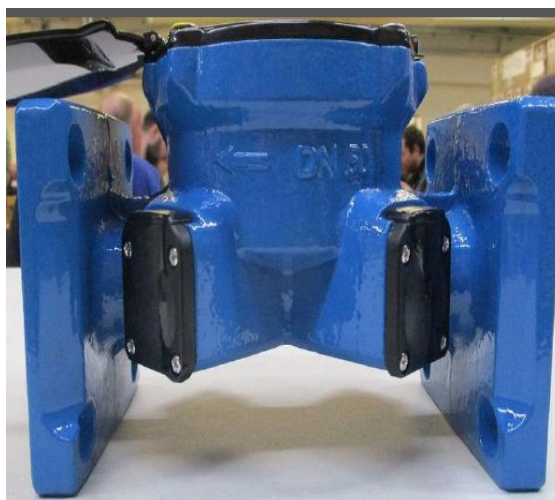

Sealing is done at one point as indicated in the sealing arrangement. The calibration could not be performed/alterd without removing the seal and the top cover and a dip switch is provided to disable access to external calibration. A typical schematic diagram and photograph of sealing provision to prevent the fraudulent practices of the model is given above as Figure 2.
